

## Confirmation of Attendance

### Privacy notice

The information you are being asked to provide in this document will be shared with Walsall Council and the Department for Education, who will access information from other government departments to confirm your child's eligibility and enable this provider to claim free entitlement funding as agreed on behalf of your child and to claim Early Years Pupil Premium (EYPP) or Disability Access Fund (DAF) on behalf of your child.

### Setting and attendance details

You need to complete a confirmation of attendance form with each setting your child attends for their early education entitlement of 15 or 30 hours per week in order to ensure that funding is paid fairly between them. Your child can attend a maximum of two sites in a single day and if your child attends more than 1 setting we will split the funding fairly between the settings.

The maximum length of a funded session is 10 hours. There is no minimum session length.

Funded sessions may not take place before 6:00am, or after 8:00pm.

If a child is attending a maintained nursery or primary school, those hours count towards the child's free entitlement.

All Early Years Providers are required by law to keep a record of the children who are claiming a funded place. You must complete the form and show the provider documentation to confirm your child's legal name and date of birth. Please complete this form in BLOCK CAPITALS.

### Disability Access Fund Declaration
