

## Choosing a Holiday Playscheme

When you are looking for childcare for your child, Walsall FIS understands that it is a difficult decision. To help you we have put together a guide to helping you choose the best provision for you and your children.

If you are considering using a scheme then this fact sheet gives tips and hints on what to look for and what to ask.

### **Firstly is a holiday playscheme for you? A holiday playscheme maybe for you if:**

- You only need care during the school holidays
- You want your child to mix with other children of all ages
- You only want to drop your child off at one place

If a holiday playscheme only cares for children over 8 or only operates for 1 week a year then it doesn't need to be registered.

If it is registered with Ofsted then you maybe able to claim help with the costs. Please speak to a team member for more details.

If you decide that a holiday playscheme is for you, the first thing you need to do is establish which schemes have the vacancies to meet your needs.

The information that Walsall FIS hold about vacancies is only ever a guide and we would always recommend that you contact them directly for up to date details.

Once you have established which scheme maybe able to meet you needs, we would always suggest arranging a visit to meet them, preferably more that once and at different times of the day.

When you go to see them, if possible, take your child with you although this is more difficult as they only run during holidays.

### **When you visit the scheme you may want to look for the following:**

- Are you and your child made to feel welcome?  
Do they interact with your child?
- Do the other children look happy?  
Are they playing and talking with each other?
- How do the staff interact with the children?  
Do they have a good relationship?
- Do you like the venue? Is it big enough, clean, etc?
- What toys, books, equipment, etc are available?



## Choosing a Holiday Playscheme (continued)

### Questions you may wish to ask on your visit:

- Does the scheme need to be registered with Ofsted?  
If so can I see the certificate and report?
- How long have you been operating?
- How long have the staff been here?
- Do you have the appropriate public liability insurance?  
Can I see it?
- How much do you charge?  
What is included ie snacks, trips, etc?
- What other children will be with my child?  
What are their ages?
- How do you cater for special needs/disabilities?
- Is there an outside play area? Can I see it?

**Remember – trust your gut. If you don't think a provider is right for you and your child, you don't have to use them.**

### Ratios

Holiday playschemes should have a minimum of 2 staff on duty at any time, 1 of whom should be qualified. There should be 1 qualified member of staff to each group of 8 children.

The leader must have a minimum of an NVQ Level 3 and at least 50% of the rest of the staff must have a minimum of NVQ level 2, all must be in relevant subjects.

### Arranging childcare

Walsall FIS would always recommend that you have a contract with your provider so that you both know what is expected.

This contract should cover hours, pay, sickness, holiday pay, notice of cancellation period. You should also agree things such as discipline, what happens in an emergency and anything else that is important to you. You should agree this beforehand.

### Settling your child in

### I'm not happy with my holiday playscheme – What should I do?

If you are not happy with the scheme for any reason, we would always recommend talking to them first. It maybe just a misunderstanding of what is expected from both parties and can be easily cleared up.
